1.1 Purpose

This report summarizes how the Metro Pilot Business Interruption Fund (BIF) has worked to provide financial assistance to small “mom and pop” businesses that demonstrate business revenue losses due to direct impact from Metro rail construction. Small “mom and pop” businesses located along three rail corridors are eligible for BIF grant funding.

1. Crenshaw/LAX Transit Project
2. Regional Connector, Little Tokyo Area and 2nd & Broadway Segment*
3. Purple Line Extension Section 1, Section 2 and Section 3

The Metro Board of Directors approved PCR’s Metro Business Interruption Fund (BIF) contract at their February 28th Board Meeting for a new four-year term beginning March 12, 2019. Also approved was BIF eligibility for the Purple Line Extension Section 3 (PLE3), which is slated to be completed in 2027.

The period of this report is from January 1, 2022 – June 30, 2022. The activities summarized include number of applications submitted, community outreach and communications, grantee statistics, financial data and payments. Metrics on client satisfaction and general program observations are also reported. Further, included is a business profile on a BIF grantee.

*Applications for 2nd/Broadway are no longer being accepted. Project area eligibility for the 2nd/Broadway segment of the Regional Connector ended June 30, 2017. Information shown in this report is reflective of its historical performance.

Figures reported are indicative of applications that have been approved.



7.1 Quarterly and Program to Date Community Outreach and Communication Activities

During this reporting period, a total of **11** outreach activities occurred. PCR participated in: **three** outreach events in **Crenshaw/LAX (CLAX)**, **three** outreach events in **Purple Line Extension Section 1 (PLE1)**, **three** outreach events in **Purple Line Extension Section 2 (PLE2)**, **two** outreach events in **Purple Line Extension Section 3 (PLE3)**, **0** outreach events in the **Little Tokyo Area of the Regional Connector (LTRC)**. As of this reporting period, outreach events continued to be conducted virtually as construction progressed on all corridors and the COVID-19 pandemic continued. All businesses remained open and operating practicing social distancing and mask mandate protocols as per State of California, Los Angeles County and City of Los Angeles officials. In- person direct canvassing on all corridors is limited or on an “as necessary” basis only. Outreach efforts included a social distancing format utilizing email, phone or other online contact. Community meetings on all corridors are hosted in an on-line webinar format. Most site visits continue to be drive-by confirmations but if conducted in person, social distancing protocol and face coverings are required. The Metro **CLAX** Community Construction team hosts Community Construction Update meetings virtually on a bi-monthly basis with updates on the entire **CLAX** corridor. However, internal construction update meetings with Metro and PCR also occur. The BIF team participates on **CLAX, PLE1, PLE2, PLE3** Community Construction Update meetings virtually online.

Community Meetings/Presentations: During this reporting period, PCR participated in **19** community meetings and presentations, which could include various Chamber meetings, business expos, business organization meetings, construction update meetings, mall and strip mall tenant meetings. Participation in these community meetings are steady and consistent on all eligible corridors during this reporting period. All community meetings were hosted remotely in an online format due to the continuation of the COVID-19 pandemic. All three corridors- **CLAX, PLE1, PLE2, PLE3 and LTRC** offer their construction update meeting power point presentations by email and online at the Metro website for interested parties. **PLE3** Construction Update meetings are offered quarterly as part of the **PLE1** and **PLE2** meetings.

Direct Canvassing Efforts: During this reporting period, Lead **CLAX and PLE3** Business Advisor Charles Boyd, Lead **PLE1** Business Advisor Brian Lazo, and Lead **PLE2** Business Advisor, Darrell Smith conducted **24** direct canvassing days. **CLAX** Business Advisor Andre Hardy also participated in these efforts. Outreach activities were also conducted by phone, email or online format for the Business Advisors on all corridors. Outreach efforts on **PLE3** are in the early stages as heavy construction has just begun and consist of developing the client database and identifying contact points. Additionally, all Business Advisors continued to take photos of direct construction activity ongoing and occurring during this reporting period.

Outreach Partnerships with the BSC and Eat, Shop, Play: PCR continues to work closely with the BSC on the **CLAX** corridor to encourage small business owners to get the assistance they need to help with their general business operations, marketing plan, website development and financial document preparation as well as assistance with applying to the BIF. Referrals between the BIF program and the BSC are a partnership and continue. PCR's relationship with Metro's Eat, Shop, Play program on all three corridors has proven to be a valuable tool for referring small business owners for help and assistance in marketing their business during construction activities. Metro's Eat, Shop, Play provides multiple ways for small business owners to participate. During the COVID-19 pandemic, all Eat, Shop, Play events are offered as online marketing initiatives. PCR supports and participates in Metro's Eat, Shop, Play initiatives on all corridors. Metro's Eat, Shop, Play program representatives continue to make direct referrals to the Metro BIF for those small business owners impacted by construction activities.

Metro Sponsored BIF Information Workshops: Each calendar quarter, Metro has historically sponsored a series of BIF Information Workshops in each of the three corridors. These workshops have proven to be very effective in presenting BIF program details to potential applicants with an opportunity for Q & A. During this reporting period, **zero** Metro BIF Information Workshops were held. With the ongoing COVID-19 pandemic, all in-person workshops were put on hold. Discussions about offering remote and online workshops continue and future dates are being discussed. PCR's strategy is to target specific area small business populations that are currently experiencing or about to experience significant construction impacts including street closures to ensure that they are aware of the BIF program, determine eligibility and encourage eligible small businesses to apply. With the start of construction activities on **PLE3**, virtual workshops are being planned-one for the building property managers in the Westwood area on Wilshire Blvd. and one for the tenants in the 10921 Wilshire Blvd. building where construction activities are beginning. There are no current BIF Information Workshops being planned.

PCR Sponsored BIF Application Workshops: PCR sponsored Application Workshops provide the opportunity to work one-on-one with small business owners to complete their Metro BIF application and address any questions or concerns on the spot. Previous Application Workshops were well attended and provided an intimate working space to submit applications directly to the BIF team. During this reporting period, PCR sponsored **zero** BIF Application Workshops due to the COVID-19 pandemic, however, with construction impacts progressing on the **PLE2** corridor and beginning on the **PLE3** corridor, application workshops are being considered as part of the Information Workshops to be offered remotely online within the next 6 months. For **CLAX**, workshops have been previously hosted as joint events with the BSC and Eat, Shop, Play. For **PLE2**, workshops were hosted as joint events with Eat, Shop, Play. Future workshops for **PLE3** are also expected to be a joint effort with BIF and Eat, Shop, Play.

Media Photo Op: No media photo ops occurred during this reporting period. Media Photo Ops were a great way to feature Metro BIF grantees and offer good PR for the BIF program, especially in the early months of the program. When small business owners "saw" other small business owners receiving BIF grant awards from PCR, Metro and political officials, it validated the BIF grant program and encouraged additional business owners to apply. Photos can also be especially helpful when starting up the BIF program on a new rail corridor to raise awareness and interest.

Metro BIF Newsletter: In addition to "The Source," Metro has established a BIF newsletter which is e-blasted quarterly to Metro's various social media networks, constituents, stakeholders and customers. The newsletter includes updated information on program dollar and grant amounts, measures of effectiveness (MOEs) as well as a grantee success story. This newsletter provides high visibility and awareness for the BIF program. PCR also provides BIF information updates and grantee success stories periodically in its company bi-monthly e-newsletter.

















Figure 2. Grant Disbursement by Years in Business





Figure 3: Grant Disbursement by Gender





Figure 4: Grant Disbursement by Veteran Status





Figure 5: Property Owner vs. Business Owner





Figure 7: Grant Disbursement by Ethnicity








Question 1: How would you rate your overall satisfaction with us?




Question 2a: Please rate us on the following experiences: Customer Service




Question 2b: Please rate us on the following experiences: Professionalism




Question 2c: Please rate us on the following experiences: Quality of Services








Question 7: Are you getting the assistance you need at this time?



11.1 Frequently Asked Questions (during this reporting period)

- a. No questions asked this reporting period.

12.1 Project Updates and Observations (as of this reporting period)

- a. Metro construction activities continue to progress on all corridors during this reporting period. The COVID-19 pandemic remains a major public health and safety concern keeping mask protocols and social distancing procedures in place. As such, Metro construction update meetings remain as virtual webinars. Small businesses that continue to be impacted by Metro's construction activities and experienced revenue loss are able to apply for grants for impact during the COVID-19 pandemic period if their business was allowed to be open and operating. The Construction Impact During COVID (CIDC) analysis calculates available historical data and for repeat grantees, uses historical revenue data from previous grant awards. One-on-one outreach and other in-person meetings continue to be limited utilizing COVID-19 safety protocols. PCR conducts most outreach and documentation collection remotely by email, conference calls and virtual platforms.
- b. On the Crenshaw/LAX (CLAX) rail corridor, technical and communications work is ongoing along the entire alignment. Work as of February 2022 has been completed aside from various punch list items.
- c. Construction activities on Purple Line Extension Section 1 (PLE1) continue to progress. A work zone is in place at the Wilshire/Rimpau intersection until March 2022. Appendage construction is ongoing at the Wilshire/La Brea station and will continue into first quarter of 2022. Excavation and hauling activities with intermittent lane closures and reductions resume at the Wilshire/Fairfax and Wilshire/La Cienega station areas to support subsurface investigation work along the tunnel alignment. PLE1 is scheduled to open in 2024.
- d. On Purple Line Extension Section 2 (PLE2) construction activities continue. The Reeves Drive closure is open for public access however, some intermittent closures remain in place. The long-term traffic control configuration for the area between Avenue of the Stars and Solar Way is ongoing to facilitate excavation of that station. Both tunnel boring machines continue eastbound with good progress to breakthrough at Wilshire/La Cienega station on PLE1 in about two years. PLE2 is scheduled to open in 2025.
- e. Pile installation at UCLA Lot 35 (Westwood/UCLA station) is complete however, piling continues on the north side of Wilshire Blvd. between Westwood Blvd. and Gayley Ave. resulting in lane reductions on Purple Line Extension Section 3 (PLE3). Temporary lane reductions are occurring on Wilshire Blvd. between Shelby Ave. and Glendson Ave. for geotechnical investigation work. PLE3 is scheduled to open in 2027.
- f. For the Little Tokyo Area of the Regional Connector (LTRC) the westbound directional closure along 1st St. between Vignes St. and Alameda St. continues through August 2022. The Little Tokyo stop of the Gold line remains obstructed due to work at the Mangrove station yard. To accommodate riders, a bus shuttle service is provided. Targeted operational date for the Regional Connector is scheduled for early 2023.
