72 Hour Extended Parking Permit Protocols and Guidelines

The Los Angeles County Metropolitan Transportation Authority adopted a parking ordinance that limits transit user parking to a maximum of 72 hours in the same lot. Extended parking is available at certain Metro parking facilities (Exhibit A) and must be approved by Metro prior to parking for an extended time. Extended parking permits are subject to approval and available for Metro transit patrons. A TAP card is required for extended parking permit authorization.

Extended parking is defined as parking in the same space, lot or within a distance of five hundred feet of the place of initially parked for longer than 72 hours and up to a maximum of 15 calendar days. Parking for an extended period of time will require a permit issued by Metro.

Vehicle owners may obtain a permit allowing for extended parking by completing the Extended Parking Permit Authorization Form and emailing it to Parking@Metro.net. A permit is valid for the approved specified time up to 15 calendar days. Applications should be submitted no later than 10 business days prior to the first day of requested extended parking.

Customers who are issued an extended parking permit may park in any available, non-reserved parking space. Parking is on a first-come, first-served basis and is not guaranteed. This is the only parking permit that allows parking in excess of 72 consecutive hours. Permits are only valid for the dates issued and are only valid for the assigned vehicle, identified by license plate, and are non-transferable.

The customer will be required to print out the Extended Parking Permit for their reservation and display the permit through the front windshield of the vehicle with the permit facing outward and clearly displaying the permit number. Failure to display a valid permit may result in citation and/or tow. Ridership verification failure may result in a citation.
